ESFRI is working on the preparation of the ESFRI Roadmap 2018. The entire process involves monitoring of the existing projects and landmarks and the update of the landscape analysis (see ESFRI roadmap 2018 public guide "[Guide for Applicants](#)" for more details).

The main goal of the workshop is to strengthen the dialogue between **ESFRI** and **Environmental Research Infrastructures** to clarify the ESFRI process for the preparation of the ESFRI roadmap 2018 and to contribute to the updated landscape analysis. It is expected that common issues and specific aspects could be discussed and specific messages could be passed from the Environmental Research Infrastructures to ESFRI in particular regarding crosscutting aspects: innovation, socio-economic impact, IPR and legal issues, Big data and e-needs + position in EOSC, regional impact, Pan-European dimension, Global dimension.
